If ingested, seek medical advice immediately and show the container or the label.

7.2 Conditions for safe storage

Keep container tightly closed. Keep container in a cool, well-ventilated area. Keep away from direct sunlight. The product is shipped as a lyophilized powder at room temperature. Upon receipt, the lyophilizate should be stored at -20°C. Protect from moisture. Protect from light and moisture
